
No-GWC-2021(5) ICD-102011-4256-B1:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Child Development Project Officer (Female), Class II, in the General State Service, under the Commissionerate of Women and Child Development, Gujarat State, Recruitment Rules, 2016, namely:-

1. These rules may be called the Child Development Project Officer (Female), Class II in the General State Service, under the Commissionerate of Women and Child Development, Gujarat State, Recruitment (Amendment) Rules, 2021.
2. In the Child Development Project Officer (Female), Class II, in the General State Service, under the Commissionerate of Women and Child Development, Gujarat State, Recruitment Rules, 2016 (hereinafter referred to as "the said rules"), in rule 2, in clause (a), -
 - (i) for the words "of proved merit and efficiency", the words, brackets and figures "who possesses 'good' benchmark for being considered fit for promotion within the zone of consideration as laid down in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967" shall be substituted;
 - (ii) in sub-clause (iv), after the words and figures "University Grants Commission Act, 1956", the words, "or possess an equivalent qualification as recognised by the Government" shall be inserted.

3. In the said rules, for rule-3, the following rule shall be substituted, namely: -

“3. The appointments by direct selection and by promotion shall be made in the ratio of 1:2”.
