No.GWC-2023(1) ICD-102013-1642-B:-In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Programme Officer / Assistant Director, Class I, in the General State Service, under the Commissionerate of Women and Child Development, Recruitment Rules, 2016, namely: -

1. These rules may be called the Programme Officer/ Assistant Director, Class I, in the General State Service, under the Commissionerate of Women and Child Development, Recruitment (Amendment) Rules, 2023.
2. In the Programme Officer/Assistant Director, Class I, in the General State Service, under the Commissionerate of Women and Child Development, Recruitment Rules,

2016 “(hereinafter referred to as “the said rules”), in rule 2, in clause (a),”

- i. for the words “by promotion of a person of proved merit and efficiency”, the words, brackets and figures, “by promotion of a person who possesses ‘good’ benchmark for being considered fit for promotion within the zone of consideration as laid down in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967” shall be substituted;
 - ii. In sub-clause (i), for the words, “in the Gujarat Integrated Child Development Service” the words, “in the General State Service” shall be substituted.
3. In the said rules, for rule 3, the following rule shall be substituted, namely: -
- “3. The appointments by promotion and direct selection shall be made in the ratio of 3:1.”.
4. In the said rules, in rule 4, in sub-rule (b),
- i. in clause (1), for sub-clause (ii), the following sub-clause shall be substituted, namely:-

“(ii) have about three years’ experience in the field of Integrated Child Development/Child health/ Nutrition /Health Education in Government /Local Bodies /Government Undertaking /Board / Corporation/Limited Company established under the Companies Act, 2013 /University /Registered Non-Government Organisation on the post which can be considered equivalent to the post not below the rank of Mukhya Sevika, Class III, recognised by the Government; or”;


- ii. in clause (2), for sub-clause (ii), the following sub-clause shall be substituted, namely:-

“(ii) have about five years’ experience in the field of Integrated Child Development /Child health / Nutrition /Health Education in Government /Local Bodies/Government Undertaking / Board/ Corporation /Limited Company established under the Companies Act, 2013 /University /Registered Non-Government Organisation on the post which can be considered equivalent to the post not below
